# The CyberSecura start-up/TPE is incubating its launch in Canada by taking part in the international incubation program Faise.

CyberSecura, which specialises in consulting, service and support for cybersecurity and GDPR compliance professionals, is preparing for the internationalisation of its service offerings and expertise in Vancouver.

**GRENOBLE, June 08, 2021** - CyberSecura recently took part in the international incubation programme offered by Faise, an acronym for French Alps International Softlanding Exchange. Faise's international incubation program aims to help French start-ups explore international markets before setting up shop. ### Exporting a hybrid offer

CyberSecura currently provides its services via a cross-channel strategy: the company carries out its audits and support services both face-to-face and remotely via digital communications media. #### The internationalisation of the GDPR

The General Data Protection Regulation (GDPR) is a regulation that all companies, even those outside the European Union, must comply with if they process personal data of European citizens. Although European companies are already subject to this regulation, this is not always the case for non-EU companies wishing to export their activities to Europe. CyberSecura wants to internationalize the GDPR by assisting Canadian companies in their compliance, thus allowing them to export their activities to the European Union. Compliance with the GDPR is an aspect that requires very specific and precise skills. Indeed, although Quebec is also subject to a privacy policy, the CAnLII (Act respecting the protection of personal information in the private sector), the latter is not sufficiently protective and does not cover enough aspects to be equivalent to the GDPR.
