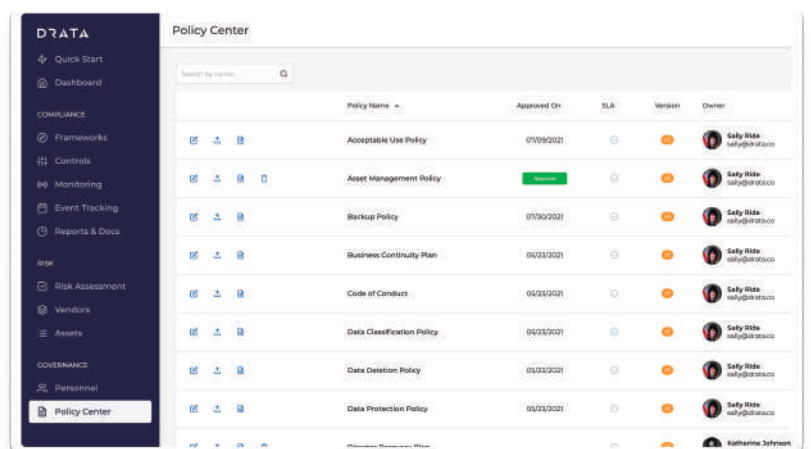
Controls Map Across Frameworks

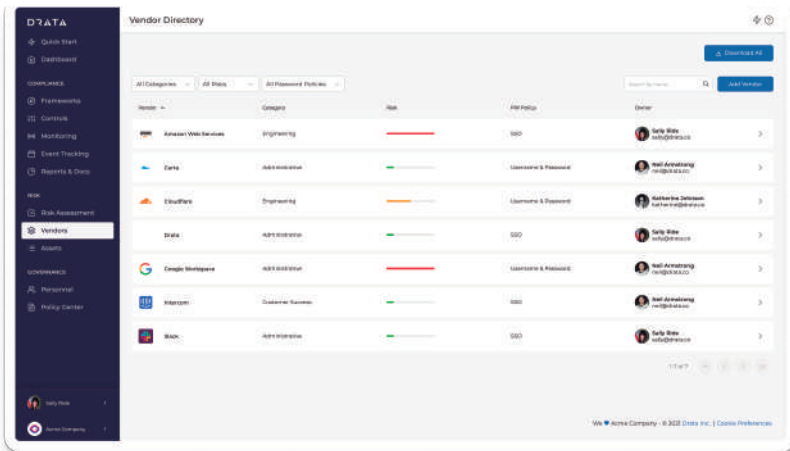
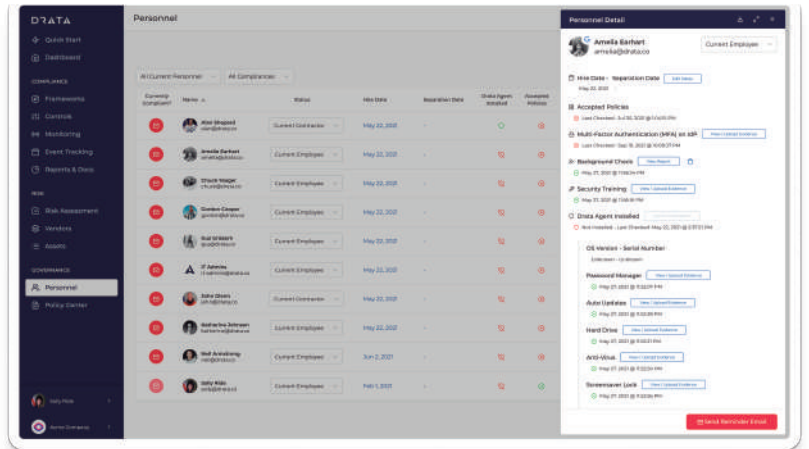
Drata's policy center will generate customized policies for your company's stage, business, and tools.

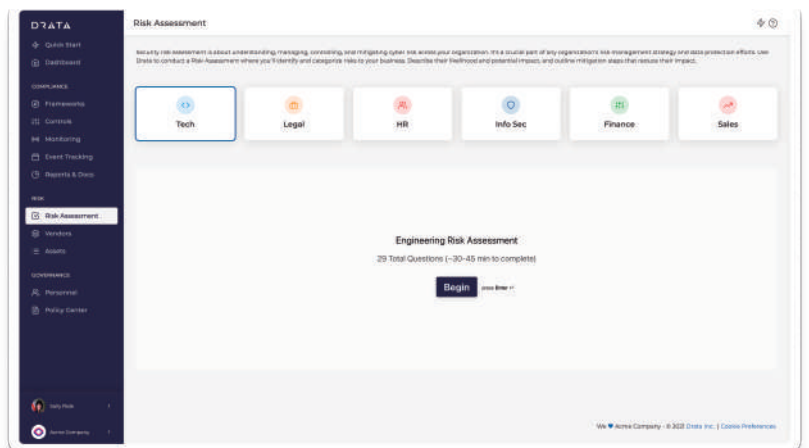


Streamlined Vendor Management Directory


Risk Assessments
